WHEREAS under the Government of West Bengal, Labour Department Order No. 1688 - IR dated 06.09.1999 the Industrial Dispute between M/s Turturi Tea Estate, (owned by Alipurduar Tea Co. Ltd.), P.O. Hatipotha, Dist. Jalpaiguri and 10 (ten) workmen represented by Dooars Cha Bagan Workers Union, P.O. Alipurduar, Dist. Jalpaiguri regarding the issue mentioned in the said order, being a matter specified to the Industrial Dispute Act, 1947 (14 of 1947), was referred for adjudication to the Judge, Sixth Industrial Tribunal, Jalpaiguri.

Order No. 105 dt. 21/11/2019

Today is fixed for passing necessary order. The employee and the employer have not taken any steps today. None appeared on repeated calls.

On careful perusal of the record it is found that a copy of Order No. 1688-I.R. dated 06/09/1999 of the Govt. of West Bengal, Labour Department, Kolkata, was received on 21.09.1999. Accordingly, the case was started and notices were issued in Form No. D2 fixing 04/07/2000 for SR, appearance and for further order. It is found that notices were served and both the parties appeared. Since last few dates no step has been taken by the employee and employer. Therefore, it is clear that the workmen has no interest in the further proceeding of this case and there is also no reasonable ground to keep this case pending any more.

Under such circumstances, I have no other alternative but to hold that the Industrial Disputes raised in between the parties to this case is no longer in existence and accordingly the case is to be disposed of as per provision of Rule-22 of the West Bengal Industrial Disputes Rules, 1958. Hence it is

ORDERED

That this Industrial Dispute between the parties to this case is no longer in existence and accordingly "No Dispute Award" is passed. The case is disposed of accordingly.
