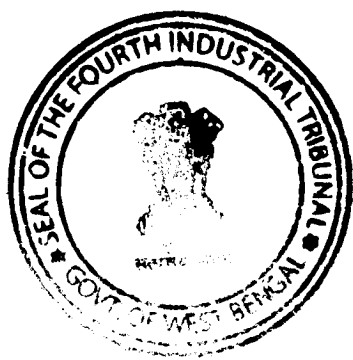

It shows that notice sent to the said association through the postal department has duly been served. As regards the notice sent to the M/s. Julien Day School vide office memo No. 882-L.T. dated 05.07.2019 one copy of the postal 'Track Consignment' is received from the office and it appears from said document that the notice issued upon the school has been delivered on 15.07.2019.

It depicts that parties are absent since 21.05.2019. Even after service of notice to show cause as stated above none of them has appeared or shown any cause of absence. Their absence is giving rise to an inference that the industrial dispute under reference is no longer in existence and accordingly, the case is required to be disposed of.
