Today is fixed for hearing of Union's petition dated 10.06.2019.

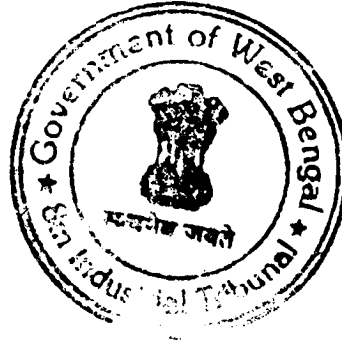
Ld. Lawyers on behalf of the Union "Not Pressed" the petition dated 10.06.2019 and petition dated 25.07.2019.
