On perusing the record, I find that the case is pending for evidence on merit but both sides have not been attending for a long time and accordingly I hold that they are not interested to proceed with this case and the industrial dispute between them is no longer in existence.

Hence, it is

ORDERED

that the case No. 03/12 under Section 2A(2) of The Industrial Disputes Act, 1947 is dismissed against the Opposite Parties for nonprosecution.

It is held that the industrial dispute between both the parties of this case is no longer in existence.

Let this order be treated as an award.
