ORDER

WHEREAS an industrial dispute existed between Shree Jain Hospital and Research Centre, 493B/12, G.T. Road (S), Distt. - Howrah, Pin - 711102 and Sri Chanchal Singh, 62/2/1, Atindra Mukherjee Lane, Distt. Howrah, Pin - 711102 regarding the issue, being a matter specified in the Second schedule to the Industrial Dispute Act, 1947 (14 of 1947);

AND WHEREAS the workman has filed an application under section 10(1B) (d) of the Industrial Dispute Act, 1947 (14 of 1947) to the Second Industrial Tribunal specified for this purpose under this Deptt.'s Notification No. 1085-IR/12L-9/95 dated 25.07.1997.

AND WHEREAS, the Second Industrial Tribunal heard the parties under section 10(1B) (d) of the I.D. Act, 1947 (14 of 1947) and framed the following issue dismissal of the workman as the "issue" of the dispute.

AND WHEREAS the Second Industrial Tribunal has submitted to the State Government its Award dated 26/08/2022 under section 10(1B) (d) of the I.D. Act, 1947 (14 of 1947) on the said Industrial Dispute vide memo no. 1342 - L. T. dated 30/08/2022.

Now, THEREFORE, in pursuance of the provisions of Section 17 of the Industrial Dispute Act, 1947 (14 of 1947), the Governor is pleased hereby to publish the said Award as shown in the Annexure hereto.

The O.P. company has filed written statement along with the copies. Let it be kept with the record.

The petitioner is absent and the Ld. Lawyer for the petitioner is also absent and no step is taken for the petitioner. On perusing the record I find that on the last two occasions also the petitioner did not appear.

So considering the conduct of the petitioner, I hold that the petitioner is not interested to proceed with this case further and he is absent for the last three days without any explanation.

On perusing the record I find that the petitioner has filed this case under Section 10(1B)(d) of The Industrial Disputes Act, 1947 against the O.P. company but considering the above mentioned conduct of the petitioner, I hold that the petitioner is not interested to proceed with this case.

Hence, it is

ORDERED

that the Case No. 19 of 2022 under Section 10(1B)(d) of The Industrial Disputes Act, 1947 is dismissed for default against the O.P. company with cost.


Let this order be treated as an Award.
