
NOTIFICATION

WHEREAS, the Governor thinks fit so to do in the interest of Public Service;

NOW, THEREFORE, in exercise of the power conferred by Sub-Section (2) of Section 4 of the West Bengal Shops & Establishments Act, 1963 (West Bengal Act XIII of 1963), the Governor is pleased hereby to exempt, all classes of petrol and diesel pumps (filling station) situated within the areas of the concerned assembly constituencies in the state, on the occasion of Elections to W.B. Legislative Assembly from 56-Samserganj, 58-Jangipur Assembly Constituencies and Bye-election to W.B. Legislative Assembly from 159-Bhabanipur Assembly Constituency to be held on 30.09.2021 (Thursday).

The filling stations are granted exemptions from the operations of provision of Sub-Section (2) of Section 6 of the said Act, subject to the condition that any work done beyond eight and half hours a day or forty eight hours a week shall be regarded as overtime work for payment of overtime wages under section 13 of the said Act.


