NOTIFICATION

No. Labr./732/ESI(Estt.)/28011(13)/1/2022 Part-I Dated 21.10.2022. – In exercise of the power conferred by the proviso to article 309 of the Constitution of India, the Governor is pleased hereby to make, with effect from the month of October, 2022, the following amendment in the West Bengal Employees' State Insurance Medical Service (Cadre, Pay, Allowance and Recruitment) Rules, 1978 (hereinafter referred to as the said rules) :-

Amendment

In the said rules, for rule 14, substitute the following rule :-

“14. **Age of superannuation** : Notwithstanding anything contained in any other rules for the time being in force, the age of superannuation of a Medical Officer of the West Bengal Employees' State Insurance Medical Service shall be the age of sixty-five years”.
