ORDER

WHEREAS, the Public Service Commission, West Bengal has recommended a total number of 07(Seven) qualified candidates for appointment in the West Bengal Employment Service, selected on the basis of West Bengal Civil Service (Exe.) Examinations, 2021 (Group-A Services), vide their Memo No. A-177-P.S.C.(A) dated 13.09.2023;

WHEREAS, this Department had started the appointment procedure after receiving the above mentioned letter from Public Service Commission, West Bengal;

WHEREAS, all the candidates as recommended by the Public Service Commission, West Bengal were called for Document Verification;

WHEREAS, Sri Ranjan Roy, S/o. Sri Dharendra Nath Roy bearing Roll No. 0142905 one of the candidates, selected for appointment to a post of Employment Officer reserved for SC(LD&CP) category in the West Bengal Employment Service selected on the basis of results of West Bengal Civil Services (Exe.) Examinations, 2021, conducted by Public Service Commission, West Bengal, was present in document verification and medical examination process for the aforesaid appointment;

WHEREAS, Sri Ranjan Roy submitted duly filled in PVR form to this Department, which was sent to the respective office(s) of Police Authority for verification of antecedents and character i.r.o. Sri Ranjan Roy;

WHEREAS, the members of the Medical Board of Medical College & Hospital, Kolkata thoroughly and meticulously examined Sri Ranjan Roy, on 29.01.2024 and 02.02.2024 and vide their Memo. No. 28/12/MCH/8350 dated 06.07.2024, the Medical Authority communicated that he is suffering from "cubitus valgus deformity of left elbow joint" which can be corrected by surgical intervention;

WHEREAS, vide Memo. No. A-107-P.S.C.(A) dated 13.08.2024, Public Service Commission, West Bengal has mentioned that the candidature of Sri Ranjan Roy may now be cancelled by this Department as he was declared unfit to avail PH quota by the concerned specialists of Central Medical Board, as it is not admissible to this person whose disability is less than 40% in terms of WCD&SW Department's Notification No. 4080 SW/DP-6/87 dated 27.09.1989.

HENCE, the Governor has been pleased to cancel the candidature of Sri Ranjan Roy (details of the candidate is mentioned in the table below)
