MEMORANDUM

In connection with the Municipal Bye - Elections, 2022 to Ward No. 6 of Asansol Municipal Corporation in the district of Paschim Bardhaman and Ward No. 14 of Bongaon Municipality in the district of North 24 Parganas scheduled to be held on **21st August, 2022 (Sunday)** vide W.B. State Election Commission Notification No. 2310-SEC/1E-99/2021(Pt.-1) dated 28.07.2022, in compliance with the State Government Notification No. 791/MA/O/C-4/1E-1/2008(Pt-1) dated 27.07.2022, the undersigned is directed to declare that, it has been made obligatory on the part of the employers of any business, trade, industrial undertaking or any other establishments in all areas pertaining to two Municipalities, to which elections have been notified, to grant paid holiday on the day of Poll to their workmen who are voters in the said constituency areas, so as to enable them to exercise their right of franchise.

The daily wage / casual workers are also entitled for a holiday and wages on poll day as provided in Section 135B of the Representation of Peoples Act, 1951.

I am, therefore, directed to issue instruction to all shops, commercial and industrial establishments, in the areas pertaining to the Municipalities, to which elections have been notified and in whose units Sunday, the 21st August, 2022 is a working day, to grant a paid holiday on 21.08.2022 (Sunday) to all categories of workers and employees who are voters in the said constituency areas to enable them to exercise their right of franchise in the election.


