NOTIFICATION

WHEREAS, the Governor thinks fit so to do in the interest of Public Service;

NOW, THEREFORE, in exercise of the power conferred by Sub-Section (2) of Section 4 of the West Bengal Shops & Establishments Act, 1963 (West Bengal Act XIII of 1963), the Governor is pleased hereby to exempt, all classes of petrol and diesel pumps (filling station) situated within the area of the Ward No. 6 of Asansol Municipal Corporation, Paschim Bardhaman and Ward No. 14 of Bongaon Municipality, North 24 Parganas to be held on **21st August, 2022 (Sunday)** vide W.B. State Election Commission Notification No. 2310-SEC/1E-99/2021(Pt.-1) dated 28.07.2022, in compliance with the State Government Notification No. 791/MA/O/C-4/1E-1/2008(Pt-1) dated 27.07.2022.

The filling stations are granted exemptions from the operations of provision of Sub-Section (2) of Section 6 of the said Act, subject to the condition that any work done beyond eight and half hours a day or forty eight hours a week shall be regarded as overtime work for payment of overtime wages under section 13 of the said Act.
