ORDER

In terms of sub-rule(6) of rule 3 of the West Bengal Services (Duties Rights & Obligation of the Government Employees) Rules, 1980 and the instructions issued thereunder, every Government employee (other than a group D employee) is required to submit declaration of assets once in every year by the 30<sup>th</sup> April of the following year.

In view of the prevailing **COVID-19** pandemic situations, said date was extended till 30<sup>th</sup> June, 2021 in terms of Memo No. **1451-F(P<sub>2</sub>)** dated 30.04.2021.

Now, on further review of the present situations, the last date for submission of declaration of assets in respect of officers and staff belonging to Group-A, B and C is hereby further extended up to 30<sup>th</sup> September, 2021.

Other stipulations for submission of such declaration shall, however, remain unchanged.


